Anti-Bullying Bill of Rights Self-Assessment

- This self-assessment will assist in determining the status of Passaic Valley Regional High School in complying with the Anti-Bullying Bill of Rights Act (ABR). The Anti-Bullying Specialist conferred with the School Safety Team to complete the self-assessment.
- The ABR grade for our school will be determined primarily through a self-assessment of the school's implementation of the ABR using the tool titled *School Self-Assessment for Determining Grades under the ABR*.
- The Self-Assessment must be made available for public comment and approved by the district board of education.
- The chief school administrator will be required to certify the electronic submission of the school's Self-Assessment and *Statement of Assurances*.



The following is the scoring criteria for each Core Element:

- ▶ 0 = Does Not Meet the Requirements
- ▶ 1 = Partially Meets the Requirements
- ▶ 2 = Meets All Requirements
- ▶ 3 = Exceeds All Requirements
