# 1. <u>Discussion of 2020 Fiscal Year End Audit, Acceptance of Said Audit & Approval of the 2020 Fiscal Year End Corrective Action Plan</u>

WHEREAS, The Board of Education of the Passaic County Regional High School District #1 (the Board) caused an annual audit of the district's accounts and financial transactions to be conducted by a public school accountant for the 2019-2020 fiscal year pursuant to NJSA 18A:23; and

WHEREAS, said "Comprehensive Annual Financial Report" and "Auditor's Management Report" for the fiscal year ended June 30, 2020, were filed in duplicate with the Office of the Commissioner on March 1, 2021, pursuant to NJSA 18A:23-3; and

WHEREAS, a presentation of the audit with discussion of the district's fiscal status, audit findings and recommendations were made to the Board and public by the School Business Administrator at the Board Meeting of March 2, 2021; and

WHEREAS, the presentation allowed for a public discussion of the audit results including the district's overall financial position, reserved, unreserved and excess surplus fund balances, and the two (2) audit findings and recommendations, at the Regular Board Meeting of March 2, 2021; and

WHEREAS, the synopsis of the CAFR was available to the public at the March 2, 2021 board meeting with copies of the synopsis available at the offices of the School Business Administrator upon request; and
