The Superintendent, in consultation with the School Business Administrator/Board Secretary, recommended the Board approve the following resolution to participate in the ACES Cooperative Pricing System #E8801-ACESCPS.

WHEREAS "The Electric Discount and Energy Competition Act," P.L. 1999, c.23 authorized the New Jersey School Boards' Association (hereinafter NJSBA) to obtain electricity and other energy-related services for individual local boards of education on an aggregated basis; and

WHEREAS N.J.S.A. 18A:18A-11 and 40A:11-10 authorized local district boards of education to enter into cooperative pricing agreements with local government units Passaic Valley Regional High School Board of Education; and

WHEREAS NJSBA has offered voluntary participation in a cooperative pricing system for the group purchase of electrical generation and/or natural gas for consumption by the local units; any ancillary or administrative services related to the purchase of electrical generation and/or natural gas; and related energy services; and digital and electronic products and services and other technology products and programs to be purchased by local units; and services and such other items or servicesbas two or more participating local units in the system agree can be purchased on a cooperative basis; and

WHEREAS the Passaic Valley Regional High School Board of Education in the county of Passaic, State of New Jersey, desires to participate in NJSBA's Cooperative Pricing System;

NOW THEREFORE BE IT RESOLVED on December 7, 2021, by the Passaic Valley Regional High School Board of Education in the county of Passaic, State of New Jersey, as follows:

TITLE

This RESOLUTION shall be known and may be cited as the "ACES Cooperative Pricing Resolution of the Passaic Valley Regional High School Board of Education."

AUTHORITY

Pursuant to the provisions of N.J.S.A. 18A:18A-11 and 40A:11-10, the School Business Administrator is hereby authorized to enter into NJSBA's ACES Cooperative Pricing System Agreement.

NOW, THEREFORE, BE IT RESOLVED by the Passaic Valley Regional High School in the County of Passaic, State of New Jersey, that it hereby awards a contract to Athletic Fields of America for the construction the Athletic Field Improvements, in the amount of \$974,089.00, consistent with the foregoing and hereby authorizes and directs the Business Administrator to execute the same.
